Herald Harbor Special Community Benefits District

I (We), the undersigned, property owner(s) of Herald Harbor hereby petition the County Council of Anne Arundel County to amend the Herald Harbor Special Community Benefit District, in accordance with the Anne Arundel County Code, § 4-7-203, as follows:

1. The limits of the Herald Harbor Special Community Benefit District shall be modified from:

"the lands described in a deed dated July 1, 1924, recorded among the land records of the County at Liber WNW No. 89, Folio No. 224, and in a deed dated July 1, 1924, recorded at Liber WNW No. 89, Folio No. 230"

to:

"the lands shown on the plat of Herald Harbor on the Severn Sections A, B, and C recorded among the plat records of the County in Plat Book No. 4, Folio Nos. 14-17; Herald Harbor on the Severn Sections D and F recorded among the plat records of the County in Plat Book No. 4, Folio Nos. 6-7; and Herald Harbor on the Severn Section E recorded among the plat records of the County in Plat Book No. 4, Folio No. 14."

2. The purposes of the district shall be modified from:

"construction, maintenance, and repair of non-County-owned roads, streets, alleys, sidewalks, street or road signs, street or road lights, drainage ditches, and culverts,"

to:

"The purposes of the district are:

- 1. acquiring, improving, and maintaining all community-owned and leased real and personal property or any interest in real property necessary to accomplish community projects;
- 2. providing special police protection and/or community security services;
- 3. providing recreational facilities directly related to the community; and
- 4. funding the administrative expenses to carry out these purposes, including mailing expenses, secretarial costs, insurance costs, audit fees, attorney's fees, and the repayment of any loan."
- 3. The method of taxation shall be changed from a uniform assessment per platted lot, in accordance with Anne Arundel County Code, § 4-7-205(a), to a uniform assessment per improved tax account.
- 4. The Herald Harbor Citizens' Association, Inc., a civic or community association that meets the criteria set forth in the Anne Arundel County Code, § 4-7-101(d), shall be the organization responsible for administering the special community benefit district assessments in furtherance of the purposes of the Herald Harbor Special Community Benefit District.
